

KEY POINTS

Sicily Region. In **Palermo**, we met some operators and volunteers from organizations strongly committed to the protection and reception of forced migrants, including the **Centro Astalli**, the **Arci Porco Rosso club** and **Borderline Sicilia**. It is common opinion among the interviewees that the theme of mental discomfort is becoming more and more relevant in the area, intertwined with the matter of pathological addictions, which is in substantial increase. Institutions that historically have worked for the reception and social inclusion, for this reason, are increasingly confronted with the mental health of guests, and are facing real emergencies.

With the closure of many structures and the first effects of the **security decree**, many people found themselves excluded from the reception process, even in serious vulnerability conditions. In **Palermo** there are various emergency solutions, but in such contexts people are welcomed in a situation of absolute precariousness and promiscuity, they are not followed up in their specific needs and when cases of mental discomfort emerge they easily become a danger for themselves and for others.

Even when they have documents in order, access to services is inclined to encounter many obstacles: some of a bureaucratic nature, others more clearly linked to the prejudice and distrust of operators. Even the language often becomes an insurmountable obstacle, both for the actual unavailability of interpreters and mediators and the lack in resources to pay for their service, and because of the attitude of some services and professionals, who sometimes seem to hide behind the excuse of the language, so not to take charge of the situations which present further difficulties to treat.

The work behind the networking, which is continuous and intense among the operators in the third sector, still makes it possible to carry out a good monitoring of the situation and in several cases to ensure effective prevention, which has prevented some critical cases which could have led to serious problems.

However, there is a strong need to make collaboration between services, public as well as private social, more fluid and effective, at a time when the rapidly changing context poses important challenges.

GOOD PRACTICES

Palermo. The **Penc Center**, based in **the Municipality of Palermo**, at the **Guarantor of Childhood and Adolescence**, has been carrying out systematic work on the training of mediators for years. There are moments before and after each session, which explain the therapeutic plan and ideally the plan for the specific session; at the end a comparison takes place. Team meetings happen on a weekly basis. To a training part (on the interview techniques, for example), a terminological session follows in which the most common terms are explained through a further comparison that takes place between the mediators themselves. A better translation is followed focusing on the concepts and expressions which occur more often during the therapeutic interviews.

Trapani. Between July 2016 and June 2018, **MSF** opened an intercultural psychotherapy clinic in collaboration with **mental health department of Trapani hospital**; as a complementary activity of a project launched in April 2016, to assist asylum seekers in conditions of psychological fragility in 32 **CAS** present in the territory. The clinic dealt with cases reported by CAS. **MSF** oversaw a capacity building project focused on CAS operators, creating a signaling path between reception centers and local health services, in particular towards those relating to women and addiction rehabilitation services. Most of the patients treated by the clinic were asylum seekers whose application had been rejected beforehand.



Projects across the territory
Projects financed with **European funds** are currently underway to strengthen the capacity of local services to adequately identify and take charge of international protection holders affected by specific vulnerabilities in the various regional contexts.
